Subject: Regarding issuance of Permanent Affiliation under RTE Act 2009.

With the reference to the above noted subject, it is informed to you that permanent affiliation has been issued to you on the basis of following conditions and informed that if there is any ignorance found at the time of checking from the higher authorities of the department, then this affiliation should be cancelled without giving any notice. The conditions under RTE Act, which will be rectified time to time by Government, will be bound to the School Management :-

1. This affiliation has been issued for the continuance of the temporary affiliation issued before 01-04-2016. This affiliation will not be applicable after Eighth Class.
2. School will obeyed the sections of compulsory and free education of the children rights, act 2009, annexure (1) and annexure (2).
3. School will give admission to 25% weak and backward class students of total strength of the School in 1st class and give free and compulsory education to them upto higher classes and on necessity these rules will also applied for pre primary classes.
4. In regards to the children shown in para 3, as per section 12(2), Govt. will be fulfilled the loss of school and for fulfillment, school will be given a separate bank account.
5. School or Society will not collect any type capitation fees and will not take any interview from the students or parents/guardian.
6. School will not refused to admit to any student for the following conditions :
 - In the case of date of birth proof.
 - In extension of admission time period.
 - On the basis of religion, caste, birth place.
7. School will assured :
 - (a) No any student will neither be detained in any class upto completion of primary education and nor school will be cancelled out his name.
 - (b) Not any physical or mentally punishment will be given to any student.
 - (c) There is need not to given board exams upto the completion of basic education. If Punjab Govt. will did any rectification, then society will be bound to accept this.
 - (d) As per the rule 23, which child will complete his basic education, a certificate will be given to him.
 - (e) As per the sections of act, join the special needy children.

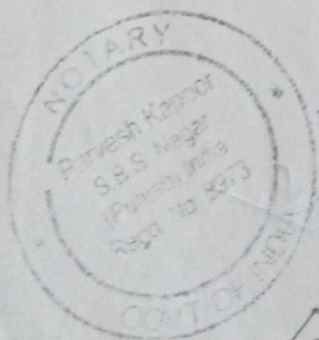

- (f) According to the act 23(1), minimum educated qualified teachers should be appointed and at the time of starting of this act, if any teacher will not have minimum qualification, then he have to get minimum qualification upto the period of 5 years.
- (g) Teacher should be complete his duties shown in the section 24(1) of this act.
- (h) Teacher should not take any type of private tuition.
8. Syllabus should be completed by the school as per given the authority.
 9. Children will be admitted in the school equally and as per the facility given in the section 19 of act.
 10. According to the section 19, school will maintain his rules and dignity.
 11. There is no un-affiliated classes taught inside and outside the school campus in the name of school.
 12. School building and other section or play ground will be used for only teaching purpose.
 13. School should be managed by registered trust under the Societies Registration Act 1860(21 of 1860) or as per the rules made by the Govt. at that time.
 14. School is not running for the profit of any individual, group or association.
 15. AS per rules, there should be right statements of accounts, which was audited and certified by C.A. Copy of statement of every account will be sent to the District Education Officer (E.E.) every year.
 16. Affiliation No. provided to you will be same and this number will be used for further conversation.
 17. School will reported the information time to time to the District Education Officer/Director of Education and school will obeyed the conditions regarding continuation of affiliation issued by State Govt./Local Authorities.
 18. Renewal of Registration of society is necessary, if any.
 19. It is compulsory to take the certificate regarding completion of computerized data of the school from M.I.S. Branch of District Education Officer (E.E.) every year.
 20. It is compulsory to take Fire Safety Certificate and building safety certificate from the concerned department and it should be renewed time to time and the copy of these certificate should be sent to the District Education Officer (E.E.) Shahid Bhagat Singh Nagar.
 21. If there is any bus or any vehicle in the school, then management will be bound to update the buses or any transport vehicles as per the instructions issued by Hon'ble Punjab and Haryana High Court, Chandigarh and Govt. of Punjab.
- Note :** Eligibility of teachers, Fees record of students and service record of teachers should be updated according the RTE Act 2009. The proceedings should be informed to the undersigned within the three months from the date of notice.
